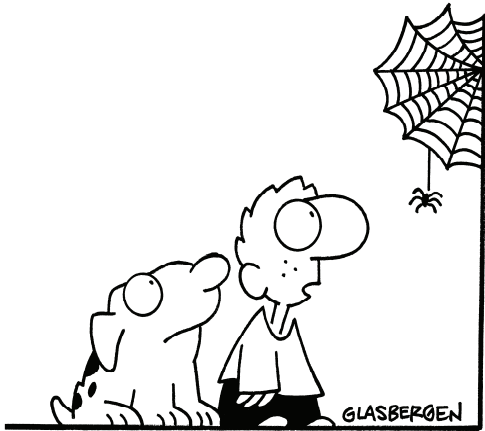

## Neighborhood Update

Management and the Board of Directors have been informed by several residents that there are ongoing issues with noise nuisances and reports of violation of the City of Emeryville's No Smoking Ordinance for multi family dwellings. All residents are encouraged to report illegal activity to the police and document the activity in writing, being as detailed as possible. Violations of the City's No Smoking Ordinance should be reported to City Code enforcement. The Association and Management will continue to address this issue as best it can, however criminal behavior and violations of city ordinances are enforced by the appropriate local agency.
